

## Notices to Exhibitors

**Refunds:** If a bitch comes in season after the Closing Date, the entry fee, less \$10, will be refunded. The Trial Secretary must be notified by 9 am on the trial date. Entry fees will not be refunded if a dog is absent, disqualified, or excused by a judge or veterinarian, or barred from competition by the Event Committee. Entry fees will not be refunded if it is impossible to open or complete the trial due to riots, civil disturbance, or other acts beyond the control of OTCGL. Owners are responsible for errors in completing entry forms. Entry fees will not be refunded for errors or cancellations after the Closing Date.

Anyone requiring special accommodations or with special requirements should contact the Trial Chair prior to the trial.

**The building will NOT be available the night before the trial.** On trial days, dogs may arrive any time prior to their scheduled judging time. Dogs not required for further judging are excused. Judges will not wait for any dog holding up a class. Owners or agents are responsible for the presence of their dogs in the judging ring when their classes are called. Dogs must be on leash or in crates except when being judged. No practicing allowed in the trial ring at any time.

OTCGL assumes no responsibility for any loss, damage, or injury sustained by exhibitors, handlers or their dogs or property. OTCGL does not agree to arbitrate claims set forth on the official AKC Entry Form for these events.

Exhibitors should follow their veterinarian's recommendation to ensure their dogs are free from parasites, communicable diseases, and have appropriate vaccinations.

Receipt of entries will be acknowledged by email. There will be a drop box at the Club for entries.

OTCGL will comply with Covid best practices recommended by the AKC and local authorities. Details will be sent before trials and are subject to change.

### **Entry Fees**

\$27 for 1st entry of each dog and \$22 for each additional entry of same dog in same event. The fee for a Rally Team is \$27 per team and the fee for Rally Pairs is \$27 per pair. Trials 1 and 2 on Saturday and the Sunday trial are separate events. Fees include: \$3.50 AKC Event Service Fee for each entry.

Do not send cash. **NOTE:** Payment by PayPal includes an upcharge of \$2 over and above the above described fee for each entry. Canadian exhibitors: make fees payable in U.S. funds. ### **General Information**

- Judging indoors on rubber matted floors
- Building opens 1 hr before the trial, closes 1 hr after last class ends.
- Move ups allowed up to ½ hr before the start of trials each day.
- Jump heights will be descending.
- Air Conditioned, handicap accessible building
- Indoor crating and seating allowed, mats under crates requested. Crates (NO DOGS) may be left in the building overnight. While indoors, dogs must be crated or on leash unless running in the judging ring or in the practice area. X-pens not allowed.

### **Ribbons and Prizes**

- Dark green ribbons awarded for qualifying scores
- Rosettes awarded to 1st through 4th place in regular classes
- Ribbons for non-regular classes
- Rosettes awarded for new titles
- Awards must be claimed at the trial
